

INTRODUCTION

1. The following Terms and Conditions, which hereby include and incorporate the provisions of the Schedule hereto ("the Schedule"), apply to the competition described at Item 1 of the Schedule ("the Competition"). A reference to these Terms and Conditions includes the provisions of the Schedule which provisions apply and are enforceable in accordance with their terms. 5. Entrants must reside in Western Australia and be aged sixteen (16) years or older in order to enter and be eligible to win the Competition.

SCHEDULE

COMPETITION
